I. INTRODUCTION

The Faculty of Education of the University of Warsaw was honored to host the 45th Annual Association for Teacher Education in Europe (ATEE) Conference 2020/2021 entitled **(Re)imagining and Remaking Teacher Education: Identity, Professionalism, and Creativity in a Changed World**. The conference took place under the conditions of a pandemic that is present all over Europe and was organized online in cooperation with the Foundation "Inspirator".

SUBTHEMES:

Professional values, professional teachers and professional teacher educators: understanding today - building tomorrow

This theme focused on explorations of personal and professional values and their implications for teacher education, teachers' professional learning, school leadership and educational policy.

Development of teacher competencies for inclusion and social justice in a changing world.

This topic concerned creating the possibility for the teacher to build a sense of self-efficacy and effectiveness. In order to achieve this, it was necessary to take into account the diverse socio-cultural context. As a promoter of social integration and justice, the teacher must have appropriate social and ethical competences.

Addressing current challenges in pre-service and in-service teacher education.

Nowadays, teachers and educators have to face changes taking place in the school and its environment. Preparing teachers to face various new challenges while maintaining a critical and autonomous attitude to the often conflicting expectations of different stakeholders has been analyzed as a fundamental task in teacher education.

IV. REVIEW OF SUBMITTED ABSTRACTS AND THE PROCESS OF THEIR APPROVAL

1. Information on the number of reviewed presentations

2. Reviewing process

The RDC chairs and members of the Scientific Committee have reviewed all abstracts submitted on time, within the specified format, directly in the EasyChair system. The Organising Committee reserved the right to reject any abstract for failure to comply with the submission guidelines. No submissions were allowed through any other channels (emails or otherwise).

Two reviewers assessed each submission using the EasyChair review form with the following text fields and scores:

For each submission, the total scores and average score were calculated by the EasyChair system. Total scores were scores chosen by each reviewer, with Reviewer's confidence in parentheses. Example: 3(4), 3(5).

The average score was weighted by reviewers' confidence and calculated using the following formula:

Average Score= $(R1_OS \cdot R1_conf + R2_os \cdot R2_conf) / (R1_conf + R2_conf)$

Where:

R1os – Reviewer 1 overall score

R1conf – Reviewer 1 confidence

R2os – Reviewer 2 overall score

R2conf – Reviewer 2 confidence

All submissions with the average score above 2.0 were accepted without further discussion. Submissions with average scores between 0.0 to 1.9 were discussed by the Scientific Committee in Poland, especially in cases where the two reviews conflicted significantly (example total scores: -1(5), 3(4), average score: 0.8). In such cases, the Scientific Committee made a decision on acceptance or rejection using the detailed reviews and own best judgement.

All participants were notified of the result of their application by e-mail. The abstracts were finally accepted after the candidate officially confirmed participation in the conference and payment of the fee (if he/she was not exempt from it).
